Community - Every day across the United States, families are quietly navigating the aftermath of a death, interacting with professionals and in need of support from their communities. Evermore is building the nation's leading resource for community-based bereavement programs, serving as a trusted partner to institutional, community, and federal leaders across the nation. Evermore authored the U.S. government's first Community Bereavement Response Guide for Child Fatalities, giving communities practical, field-tested guidance to strengthen their response when a child dies. Evermore has also hosted listening sessions, convened gatherings, and provided microgrants to innovative bereavement programs; our monthly newsletter reaches thousands of engaged people living in every state.

Advocacy - The lack of consistent, high-quality bereavement care is impacting America's health, social stability, and economic mobility. Evermore is working to change that. Evermore serves as a foremost expert on bereavement policy and systems change, advancing commonsense reforms that put families first. Evermore advised the Social Security Administration's first report on orphanhood, elevating gaps that keep an estimated \$15 billion in earned Social Security benefits from reaching more than half of America's orphaned children. Evermore also informed the Substance Abuse and Mental Health Services Administration's first grief and bereavement fact sheets and website. Evermore continues to advance reforms such as ensuring that U.S. service members can return home for two weeks when a spouse or child

Science Losing a loved one is not simply a distressing mental health event it threatens the lives, health, stability, and productivity of individuals, families, and communities. Bereavement is a universal experience with serious implications and it deserves serious research attention. Evermore is establishing the nation's authoritative research body and convener of multidisciplinary bereavement experts, grounding bereavement science in lived experience and rigorous evidence. Evermore championed the U.S. government's first comprehensive review of more than 12,000 bereavement studies, exposing serious gaps in the evidence base for psychosocial support after loss. With support from the Patient-Centered Outcomes Research Institute (PCORI), Evermore launched the Lived Experience Bereavement Research Network (LEBRN) to engage
